

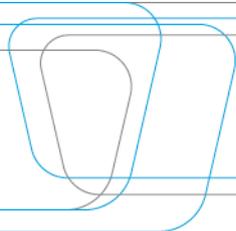

A notification by CAPFI DELEN Asset Management N.V. informing that on March 31, 2017 it holds 377.135 of the shares of JENSEN-GROUP N.V. compared to 410,000 shares disclosed in the previous notification of December 8, 2016. As a result, the threshold of 5% is crossed downwards. JENSEN-GROUP NV has 7.818.999 shares.
